**W**<u>ar Memorial Cross Will Return to Mojave</u> <u>Desert</u>: The battle over a 7-foot-high war memorial cross that wound its way from California to the Supreme Court has ended with its restoration, officials said. A settlement has been reached to return the cross to its perch atop Sunrise Rock in the Mohave Desert, The (Riverside Calif.) Press Enterprise reported. Under terms of the settlement, the National Park Service will relinquish 1 acre of land encompassing Sunrise Rock to the local post of the Veterans of Foreign Wars. In return, Henry and Wanda Sandoz will give 5 acres of land they own to the federal government. The couple promised one of the veterans who erected the memorial 78 years ago that they would take care of it after his death.

A to Increase Mental Health Staff by 1,900: Secretary of Veterans Affairs Eric K. Shinseki recently announced that the department would add approximately 1,600 mental health clinicians – to include nurses, psychiatrists, psychologists, and social workers as well as nearly 300 support staff to its existing workforce of 20,590 mental health staff as part of an ongoing review of mental health operations.

VA's ongoing comprehensive review of mental health operations has indicated that some VA facilities require more mental health staff to serve the growing needs of Veterans. VA is moving quickly to address this top priority. Based on this model for team delivery of outpatient mental health services, plus growth needs for the Veterans Crisis Line and anticipated increase in Compensation and Pension/Integrated Disability Evaluation System exams, VA projected the additional need for 1,900 clinical and clerical mental health staff at this time. As these increases are implemented, VA will continue to assess staffing levels.

"Mental health services must be closely aligned with Veterans' needs and fully integrated with health care facility operations," said VA Under Secretary for Health Dr. Robert Petzel.

"Improving access to mental health services will help support the current and future Veterans who depend on VA for these vital services."

VA will allocate funds from the current budget to all 21 Veterans Integrated Service Networks (VISNs) across the country this month to begin recruitment immediately. Under the leadership of President Obama and Secretary Shinseki, VA has devoted more people, programs, and resources toward mental health services to serve the growing number of Veterans seeking mental health care from VA. Last year, VA provided specialty mental health services to 1.3 million Veterans. Since 2009, VA has increased the mental health care budget by 39 percent. Since 2007, VA has seen a 35 percent increase in the number of Veterans receiving mental health services, and a 41 percent increase in mental health staff.

VA has enhanced services by integrating mental health care into the primary care setting, developed an extensive suicide prevention program, and increased the number of Veterans Readjustment Counseling Centers (Vet Centers). VA's Veteran Crisis Line has received more than 600,000 calls resulting in over 21,000 rescues of Veterans in immediate crisis.

"The mental health of America's Veterans not only touches those of us at VA and the Department of Defense, but also families, friends, co-workers, and people in our communities," said Petzel. "We ask that you urge Veterans in your communities to reach out and connect with VA services."

New Army Rifle/A Game Changer: No hiding place from new U.S. Army rifles that use radio-controlled smart bullets. The XM25 Counter Defilade Target Engagement System has a range of roughly 2,300 feet - and is to be deployed in Afghanistan this month. The rifle's gun sight uses a laser rangefinder to determine the exact distance to the obstruction, after which the soldier can add or subtract up to 3 meters from that distance to enable the bullets to clear the barrier and explode above or beside the target. Soldiers will be able to use them to target snipers hidden in trenches rather than calling in air strikes. The 25-millimetre round contains a chip that receives a radio signal from the gun sight as to the precise distance to the target. Lt. Col. Christopher Lehner, project manager for the system, described the weapon as a 'game-changer' that other nations will try and copy. He expects the Army to buy 12,500 of the XM25 rifles this year. 'With this weapon system, we take away cover from [enemy targets] forever. 'Tactics are going to have to be rewritten. The only thing we can see [enemies] being able to do is run away.' Experts say the rifle means that enemy troops will no longer be safe if they take cover The XM25 appears perfect weapon for street-to-street fighting that troops in Afghanistan have to engage in, with enemy fighters hiding behind walls and only breaking cover to fire occasionally. The weapon's laser finder would work out how far away the enemy was and then the U.S. soldier would add one meter using a button near the trigger. When fired, the explosive round would carry exactly one meter past the wall and explode with the force of a hand grenade above the Taliban fighter. A patent granted to the bullet's maker, Alliant Techsystems, reveals that the chip can calculate how far it has travelled. These rounds will end up costing \$15.50 apiece. They're relatively cheap. The enemy has learned to get cover, for hundreds if not thousands of years. Well, they can't do that anymore. We're taking that cover from them and there's only two outcomes: We're going to get you behind that cover or force you to flee. The rifle will initially use highexplosive rounds, but its makers say that it might make later use versions with smaller explosive charges that aim to stun rather than kill.. One of the revolutionary bullets which can be pre-programmed to explode to hit troops that are hiding.

A Claims Update: The Department of Veterans Affairs is moving a step closer to fixing a disability claims system that for years has taken in more claims than are processed. The department is about to rollout nationally a new automated Veterans Benefit Management System to make claims determinations faster and more accurate. In 2009, VA produced 900,000 claims decisions, but took in 1 million new claims. VA increased its claims decisions to 1 million in both 2010 and 2011, but then took in 1.2 million and 1.3 million new claims, respectively. The new automated system will be launched in 16 of the VA's 56 regional offices this fall to complement ongoing manual efforts, with the rest of the ROs brought onboard by 2014. VA's intent is to have no claim older than 125 days, and for every rating decision to be 98 percent accurate.

In observance of the holiday, many people visit cemeteries and memorials, and volunteers often place American flags on each grave site at national and local cemeteries. Although most of us know what is being accomplished here at home, ever wonder what is done to commemorate Memorial Day at cemeteries overseas where many of our fallen heroes are located. In all 21cemeteries worldwide have been in operation since the end of World War II. 11 are in France, three in Belgium, two in England, two in Italy, one in Luxembourg, one in Holland and one in Tunisia. These cemeteries contain the remains of veterans killed in battle from the start

day before the Memorial Day ceremonies begin school children and their parents go out and place an American flag at our guys' graves. The American Overseas Memorial Day Association (AOMDA) including some nine participation organizations is responsible for the overseas grave decoration effort The Administration revealed a new defense strategy that would shrink the Army and Marines, focus more attention on China and reduce the nation's nuclear arsenal. The plan would cut military spending by \$487 billion or about 8%- over the next ten years. The plan would cut the Army by 14%, or about 80,000 troops, and the Marines by some 10% or about 20,000 troops. Currently, approximately 80,000 U.S. troops are stationed in Europe, built it is unclear how many will remain. The Pentagon will launch a full review of the military's retirement system to get the costs for retirement program under control, however retirees already receiving benefits would be "grandfathered" into ant new system, unless the bottom falls out of the U.S. economy.

**<u>Arine Completes Walk to Arlington:</u>** Marine Corps veteran Justin Kuhel arrived at Arlington National Cemetery, completing a 17-day, 400-mile walk from his hometown of Columbus, Ohio, to help raise the nation's awareness of wounded veterans. Veteran groups were on hand at Arlington to greet Kuhel and accompany him on a visit to fallen comrades laid to rest in Section 60.

A Ruled Exempt from Automatic Budget Cuts: The Department of Veterans Affairs would be exempt from automatic, across-the-board reductions in federal budget growth that could take effect in January, The Office of Management Budget outlined that position in a letter to the Government Accountability Office, which in March asked OMB if all VA programs, including medical care, would be spared. The "sequester" was an outgrowth of last year's political battle over raising the U.S. debt ceiling, a spending cut intended to be so harsh it spurred Republicans and Democrats on Congress' "super committee" to get a deal to reduce the U.S. deficit by \$1.2 trillion. But even it couldn't induce them to compromise, and so the reductions are set to take effect in January unless Congress averts them. Under the law, however, the president can exempt certain aspects of the federal budget, including the accounts that cover military pay and veterans benefits. The VA, along with the Senate and House veterans affairs committees, have been pushing the White House and OMB for months to find out if the VA would, in fact be exempt. Although leaders from both parties initially said they were glad there was "time" between last year's "trigger" of the sequester and the date it would go into effect, few observers expect Congress to attempt to deal with it before Election Day. In fact, the matter will probably wait until December's "lame duck" session, when Congress may consider it along with a decision about whether to extend or end the Bush-era tax cuts.

**Three Korean War MIAs Identified:** The Defense POW/Missing Personnel Office recently announced the identification of remains belonging to three soldiers who had been missing in action since the Korean War. Recovered are: \* Army Cpl. Patrick R. Glennon, 18, of Rochester, N.Y. On Nov. 1, 1950, Glennon and G Company, 8th Cavalry Regiment, 1st Cavalry Division, were holding a defensive position along the Nammyon River near Unsan, North Korea, when they were attacked by Chinese forces. Glennon was listed as missing in action following the heavy fighting.

\*Army Sgt. 1st Class Richard L. Harris, 23, of Spokane, Wash. In late November 1950, Harris and elements of the 2nd Infantry Division, were in a defensive line north of Kujang, North Korea, when they were attacked by Chinese forces in what became known as the Battle of the Chongchon. It would be learned that Harris had been captured, but died of malnutrition in a North Korean POW camp on Jan. 22, 1951.

\* Army Pfc. Frank P. Jennings, 20, of Parsons, Tenn. In late April 1951, Jennings and E Company, 2nd Battalion, 7th Infantry Regiment, were battling Chinese Communist Forces near Jeon-Gog, South Korea. Jennings was reported as missing in action; his status was later changed to killed in action.

## <u>orpse Abuse Pictures Fuel Anger, NATO Exit:</u>

Photographs of U.S. troops abusing corpses, coming on top of a series of outrages this year, are likely to fuel anti-U.S. anger in Afghanistan -- and a desire in NATO countries to get out of an unpopular war. Taliban insurgents, as always, seized on the latest scandal -- exposed by the Los Angeles Times -- to condemn the "brutal and inhuman act by the American invading forces" and vowed revenge. There was also some anger on the streets of Kabul, but mass anti-U.S. protests are seen as unlikely and the biggest effect of the pictures may be in NATO countries, where polls show the long war is increasingly viewed with distaste. "In the West there was this strong idea that of course the troops came to fight terrorism but also came to help and to rebuild the country," said Martine van Bijlert of the Afghan Analysts' Network. "Incidents like this will feed into feelings at home of 'What are we doing here?'," she told AFP. For the Afghans, "it does confirm how people increasingly feel about the international and U.S. troops -- that 'they don't really care about us, that they don't treat us with respect." Now the Los Angeles Times has published pictures taken in 2010 showing soldiers posing with insurgents' bodies, one with a dead man's hand draped on his shoulder. U.S. Defense Secretary Leon Panetta said those responsible would be punished but voiced "regret" that the newspaper had published the images against the Pentagon's wishes, warning that they could prompt a violent backlash. But an immediate violent response by ordinary Afghans was seen as unlikely. More such incidents could be expected as NATO prepares to pull its troops out of Afghanistan by the end of 2014 after a war that has already lasted more than a decade, she said. "I think it is becoming increasingly clear, for the U.S. soldiers in particular who've been through so many tours in Iraq and Afghanistan, that they are extremely worn down and that the morale internally is not so fantastic." But she pointed out that they did not characterize the whole of the U.S. military. "There will always be incidents when violence in the extreme is encountered on both sides, whether it is in this case (U.S.) soldiers desecrating bodies or in another other case Taliban soldiers taking pictures of beheadings. "This is just a natural part of war."

rming the Army's Next Infantry Squad: After a decade of war, Army infantry officials want to make infantry squads more deadly by arming them with a new generation of weapons ranging from ultra-light machine guns to compact sniper rifles. Testing and fielding newer, more lethal assault weapons is just part of a larger effort to address shortcomings in the current squad formation. The Army's Maneuver Center of Excellence at Fort Benning, Ga. found 22 "capability gaps" that hinder the nine-man infantry squad's ability to be decisive in small-unit actions. That doesn't mean today's troops have major problems, just that they have room to improve. But in looking at past dismounted combat engagements, the one place we have a fair fight with the enemy -- where they have the capability to fight us on an equal footing -- is at the squad level. Benning officials would not release specifics on the 22 "gaps" identified in the assessment, but said they are spread across areas such as mobility; force protection; and weight distribution of essentials, such as ammunition, batteries and lethality.

**5 Years of Rolling Thunder:** May 27, 2012 marks the twenty-fifth year that Rolling Thunder has contributed in a big way to the tribute paid our dead veterans in the nation's capital. Approximately 900,000 participants and spectators are involved with this annual demonstration. Bikers and spectators from as far as California, Canada and Australia come to Washington D.C. to ride to the Vietnam Veteran's Memorial Wall, referred to as the "Ride to the Wall." Rolling Thunder members are Veterans, non-veterans and/or motorcyclists, but anyone can participate in the demonstration or become a member of this incredible organization as long as you believe in the issue. The purpose of this demonstration is to bring awareness to the government so full accountability can be achieved for all Prisoners of War (POW) and those Missing in Action (MIA) from all wars. chapters throughout the United States. While many members are veterans and many ride motorcycles, neither qualification is a prerequisite. All are united in the cause to bring full accountability for Prisoners of War (POW) and Missing I Action (MIA) of all wars. Their watchwords are "We Will Not Forget." In 1987 Vietnam veterans met to discuss their personal concerns about the POW/ MIOAs from the Vietnam War. They were deeply troubled by the abhorrent neglect of attention given to those who did not make it out with their lives and freedom. At the time these veterans discussed the more than 10,000 reported sightings of live Americans living in dismal captivity. Intelligence reports of these sightings were generally ignored by the government and mainstream press. The Founders of Rolling Thunder were ordinary men who understood that they had a right to have their voices heard and proceeded to lay down the plans for a gathering in Washington, D.C. during the 1988 Memorial Day weekend. They reached out to their families, fellow veterans and veteran's advocates to unify and form a march and demonstration in the nation's Capitol. Their arrival would be announced by the roar of their motorcycles, a sound not unlike the 1965 bombing campaign against North Vietnam dubbed Operation Rolling Thunder. Hence, they would call themselves "Rolling Thunder" a title that would endure time and be trademarked in 1990. Word spread quickly and by Memorial Day weekend in 1988, approximately 2,500 motorcycles from all over the country converged on Washington, D.C. to demand from our leaders a full accounting of all POW/MIAs. As the Founders of Rolling Thunder made their stand that day in front of the Capitol, they reflected thankfully for the people who came in support of the POW/ MIAs and for the unity that was felt. This was Rolling Thunder's first demonstration. Only until ALL POW/MIAs ARE ACCOUNTED FOR, it will not be their last. On that day, the foundation was laid for the annual "Ride for Freedom" to the Vietnam Veteran's Memorial Wall (also referred to as the "Ride to the Wall").

### emington will Make Army's New Carbines: The Army awarded Remington Arms Company a contract

to make tens of thousands of M4A1 carbines. Remington may end up being the only winner in what many gun makers have labeled as the Army's well-intentioned but doomed effort to arm soldiers with a better carbine. On the upside, the award means that more soldiers will go into combat with the M4A1, a SOF version of the carbine that features a more durable barrel and a full-auto capability. The Army's decision to dump the



three-round burst setting will give soldiers a more consistent trigger and better accuracy. It's part of the service's dual-path strategy to improve the individual carbine. In the end, the winner of the competition will likely lose when the Army conducts a business-case analysis comparing it to the new-and-improved carbine that emerges from the parallel effort known as the M4 Product Improvement Program. Questions have already started to surface over just how successful the PIP will be since the Army recently canceled a search for an improved bolt and boltcarrier assembly. It will be interesting to see if similar efforts to improve components such as the selector-switch assembly and the forward-rail assembly suffer the same fate. For now though, congratulations to Remington for winning a contract to make 24,000 M4A1s. More orders are likely to follow since last summer's pre-solicitation detailed a requirement for 70,000-100,000 M4A1s. This has been a long, tedious road since the Army launched its improved carbine effort in late 2008.

**I**<u>nstructions are Intended to Prevent Injury</u>: So here I am in Vietnam reading the instructions on a hand flare. Think I was on LZ Baldy at the time. The aluminum kind where ya took off the top put it on the bottom and fired it off with the palm of your hand. Next thing ya know there are several of us having a discussion about why you were only supposed to shoot it off with the palm of your hand. It said right on it DO NOT FIRE FROM LEG. We came to the conclusion that if you fired it off from your leg ya just might hit yourself in the face. So I, being either a fire team leader or squad leader at the time, decide to fire it off from my leg and see just why you're not suppose to do it that way. By the time I got around to it I had an audience of four or five guys. I placed my right leg, firmly planted on the ground, with my right foot at a right angle making sure I had a stable platform to shoot off the hand flare making sure I had all other body parts well outta the way. Kneeling on my left knee I slammed the hand flare down just above my right knee. The resulting impact, just above my right knee, was about like somebody taking a claw hammer with a full swing and hitting me on the right leg just above my right knee. My GI brain immediately started yelling at me "BACK BLAST BACK BLAST BACK BLAST DUMB ASS". For the next month or so I walked around with a perfect imprint of the bottom of a hand flare, including the writing, in black and blue and purple just above my right knee. Thanks to my NCO school training I only did this once.
